On behalf of myself and my child or ward, ("Applicant") and on behalf of our respective heirs, assigns and personal representative, I hereby agree not to sue and I fully and forever release, waive and discharge the St. Louis Soccer Club, Anheuser Busch Center and the affiliates of either or both of them and all their respective employees, officers, directors, agents and volunteers (the "Releasees") from and against all liabilities, claims, damages, costs or expenses for personal injury, including death and/ or property damage, which I or the Applicant may sustain and which are or may be caused by the act or omission of the Applicant, his fellow player, or any of the Releasees. I agree to indemnify the Releasees from any personal injury or property damage caused by the negligent or intentional act of Applicant while on or about Anheuser Busch Center premises or while participating in any Anheuser Busch Center activities.
